

DESCRIPTION OF THE INCIDENT/EVENT: Facts only

Event Title: Workers fingertip pinched between jack handle and bow shackle

<p>Initial Incident Description: A 290t strand jack, weighing approximately 250kg, was being removed from strand following completion of stressing operations. The jack was suspended by a chain block and was being guided out by hand. The I.P.s left hand was gripping the jack handle as he guided the jack off the strand. The jack has shifted, resulting in the middle fingertip of his left hand being pinched in between the bow shackle connecting the jack to a chain block and the handle of the jack. Worker attended Sydney Adventist Hospital where a specialist confirmed there was no fracture in the fingertip. The worker required surgery to repair the damaged finger nail and nail bed.</p>
