

Extra hat, same focus

You'll probably be aware by now that I have added the hat of Chief Executive Officer of the Aggregate and Quarry Association (AQA) to my responsibilities as CEO of MinEx.

I want to assure you that I feel entirely comfortable in this dual role. I am gaining the necessary backup to allow me to do justice to both positions.

It is a logical and cost-efficient arrangement. Since I took on the MinEx job 16 months ago, I have worked out of the offices of Straterra, our national organisation for the wider minerals



sector. This is now also the base for the AQA. We are sited a stone's throw from Parliament and Government officials. I've already had my first meeting as AQA CEO with a Government Minister. With AQA Board chair Jared Johnston, we saw Housing/Transport and Urban Development Minister Phil Twyford. In a few days we are seeing Infrastructure and Regional Development Minister Shane Jones.

These meetings are on issues around access to affordable resources but don't think health and safety are being neglected. I've already engaged a couple of times as MinEx CEO with Workplace Health and Safety Minister Iain Lees-Galloway.

By wearing two hats – and supported by Straterra – I am now able to engage with Government and councils with some additional grunt. Most importantly, I want to work with you in attracting and training staff, developing health and safety systems and working to keep our workers safe.

To that end, I'm thrilled to see in this newsletter the story about the Leeson trio of siblings, with the two sisters and a brother all committing to do their quarrying apprenticeship. We are also very pleased with the response we've had since a year ago launching our appeal to you to report incidents with potential for harm. One company – OceanaGold's Waihi operation is going a step further with its Vital Behaviours programme. Find out more in this newsletter.

We have also just finished our latest booklet – this one on Slope Stability. Details below.

Three young members of one family are among those who've signed up for the new industry apprenticeship scheme which MinEx has helped bring together.

Gemma, Adam and Megan Leeson have all started working over recent months at Stevenson Aggregate's Drury quarry.

All three did well at school so they see the new quarry apprenticeship scheme as a way to keep learning and building their skills.

They are expecting to do their first training as early as this month prior to commencing the apprenticeship early next year.

Stevenson Aggregate general manager Steve Ellis says the company will be supporting them through their studies.

Regs Review - what now?

As new Minister for Workplace Health and Safety, Iain Lees-Galloway saw the importance of new fit for purpose regulations for the quarrying sector and early

this year called for new regs to be implemented by Christmas. Big thumbs up there.

The question now is whether this will be done by Christmas next year.

Having extended the submission period, MBIE is yet to review the submissions and have advised us this will be completed by Christmas. So any new regs are not



likely to emerge until the middle of next year - and frustratingly, despite the Minister's deadline, I reckon we will be lucky to see the long-awaited regs before Christmas 2019.

MinEx consulted widely with industry and on 28 September submitted our position on changes we see as necessary to the Mining and Quarrying Regulations 2016. You can read <u>our submission here</u>.

It's vital we all do this

Over the last year we've been keen to get you as extractive companies to report incidents with potential for harm. I am delighted to say we've been getting a very good response. We share some of these as Safety Alerts and you all get the benefit of being able to avoid a similar situation in your own workplace – which may not end up with such a harmless outcome.

Now I want to do a shout-out about a company, OceanaGold which is taking things to the next level.



The logo 'Do it for Your Family' makes it clear what it's about – encouraging workers to report and act on anything that could contribute to a health and safety incident.

There were 15 staff or groups of staff acknowledged in the Wait Mine August Vital Behaviours page. These included:

 Notified advisor of smoke coming from 11KV UG transfer. Quick action prevented more damage.

- For going out of his normal work duties and coming down on to the floor to help the workshop when they had low staff numbers.
- On entry to ROM pad informed loader driver of large soft spot on entry ramp. Asked if it could be fixed. Done ASAP.

This is an exemplar approach to encouraging, supporting and acknowledging a very healthy health and safety culture.


