## New WorkSafe on-line CPD system

WorkSafe's new Continuing Professional Development (CPD) logbook system is now on-line. It gives CoC holders secure access to their own online log book, making it easier to monitor progress towards meeting CPD requirements. Further system information and instructions available [here](#)



You've got until February 19 to enter historic CPD learning activities (Christmas hols a good time?); then CPD logbooks for previous years will become read-only and you will only be able to enter learning activities to the current year's logbook.

As a current CoC holder you should have received an email providing you with access to the new system. If not - or if you require help with the on-line system, email [BoE\\_Secretariat@worksafe.govt.nz](mailto:BoE_Secretariat@worksafe.govt.nz) or 04 901 4980. All CoC holders are responsible for meeting CPD requirements and keeping an accurate record of CPD learning activities. You no longer need to submit CPD log books to the Secretariat, unless these are randomly selected for verification.

If you don't want to use the online system, you can still use the existing hard copy CPD log book.

An alternative is the IOQNZ on-line system, launched last February. Details [here](#). Note, you need to be an IOQNZ member to use the system.

## CoC applications, oral exams and the BOE review



WorkSafe has also been quietly launching a new website, including improved on-line [CoC applications](#).

The MinEx Board was this week advised of some of the latest figures for CoC exam pass rates. A grade quarry managers are now at 73% pass rates and B Grades are at 60%. Less than a year ago, there was a 60% failure rate for B Grades - so we are seeing considerable improvement. That said, a 40% failure rate for B Grade, including those resitting oral exams, is still too high.



That's why MinEx put a lot of effort into its submission when the Board of Examiners calling for input into reviewing CoCs.



The BOE makes its recommendations to the WorkSafe Board, which has responsibility for setting CoC requirements. Decisions are expected early in 2018 with meetings proposed throughout New Zealand to inform industry about the new requirements.

MinEx truly hopes its submission, echoed by others, has been heard. We want to see national qualifications established with a wider focus than the health and safety requirements of CoCs. The biggest challenge and potential single best outcome is to get in place good training materials that fit with extractive sector requirements.

## Trans-Tasman qualifications

One benefit of national qualifications for the extractives sector is these would allow much better recognition on the other side of the ditch - and vice versa.

Australia already has such qualifications. MinEx hears from people with Australian qualifications that aren't recognised here. And we know of those who've taken their CoCs across the Tasman only to be told these don't really count.

MinEx has told MITO, which oversees extractive industry training, that it will work to help deliver better training and improved qualifications which can be recognised both here and in Australia. Let's all get on board this train.
