MinEx has been instrumental in setting up a new advisory group with MITO, our industry trainer.

Ok, I know just because people are shuffling into a new carriage, this does not make a train move.

That said, I'm confident the <u>Extractives Industry</u> <u>Training Advisory Group</u> can work MITO to enable fairly rapid implementation of the Board of Examiners' agreed changes to CoCs.

In fact, the work has begun. The EITAG will also provide leadership on moving to a qualification based CoC system and establish the best model(s) for delivering training and assessment services in the mining and quarrying sector.

MITO is currently trialling a more flexible

If we can get this rolling, it will be especially welcome in those many workplaces in smaller or remote locations where it's hard to get learners to attend classroom-based courses. But to ensure a site-based delivery model can work as an alternative to classroom-based training, we will require increased numbers of approved workplace trainers and assessors.

This all represents considerable potential change and I want your feedback on where you would see plusses and minuses in having site-based training and assessment available as an alternative.

And, of course, I need to work with MITO to increase the pool of suitably qualified trainers and assessors should an alternative model(s) become an option.

WorkSafe ruling on mentors not helpful

We were disappointed recently when the Board of Examiners sent an email to BoE panel members telling them that they should not be mentoring oral exam candidates.

The logic was that no applicant should get an unfair advantage - that they've learnt from their studies and work experience rather than 'demonstrate an ability to remember facts.'



I've got a high regard for the BoE but I think they've made a wrong call here.

MinEx has set up a network of mentors across New Zealand in recent months to address the appalling pass rate, particularly for B Grade CoC oral exam candidates.

I think our mentors can take considerable credit for the improvement which has seen B grade pass rates go just 40% of B grade CoC applicants to more than 80% in the last quarter of 2017.

Yes, some mentors are also BoE panel members. I am sure they understand the boundaries of what is appropriate and would, for example, exclude themselves from sitting on a panel where someone they have mentored is being assessed.

I'm hoping WorkSafe will reconsider its position here.

Be responsible, not a rogue



WorkSafe recently commented that it has done a survey which identified 1,200 quarries nationwide, including several that were totally unknown at that point. I have been visiting small sites since taking on the job six months ago and while some welcome my advice, others are still trying to stay below the radar.

WorkSafe now knows where every quarry site is located, so unregistered quarries need accept they can no longer fly under ther radar.

The longer small quarries operate without health and

safety requirements in place, the more risk they create of serious injuries or fatalities. We don't want another year like 2015 when three deaths occurred in unregistered quarries.

Get on board with training yourself and your staff now, and develop the systems and plans you need. Remember, If you need any support, MinEx is happy to help.
